after FLMD and TMD are no longer using the plant, they will retain their voting rights and DWSD will need to obtain one or both of their votes to undertake any "actions or expenditures related to the plant." The letter ends with an invitation to DWSD to purchase their rights and interests in the facility.

DWSD District Manager Jeff Hodge explained DWSD's reasons for not participating in NMCI and re-capped a recent meeting with Nichols and McGrady. NMCI was not in the best interest of DWSD consumers, he said, because the anticipated operating costs of the project were too high, and it did not provide any way to re-use DWSD's treated wastewater. Hodge said based on the meeting, he was not surprised at the contents of the letter.

Later in the meeting, Hodge said he had attended a meeting of the Joint Use Committee, which oversees operations of the Tri-Lakes Waste Water Treatment Facility

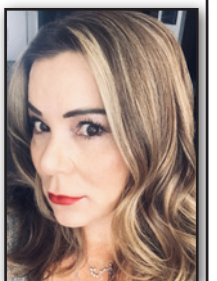
